A-FACT (American Freeman Against Communist Tyranny)

TO WHOM IT MAY CONCERN IN THE REPUBLICAN PARTY:

Years ago a popular TV program was based on the life of Herbert Philbrick called I LED THREE LIVES.

Mr. Herb Philbrick, for nine and a half years a counterspy for the FBI within the Communist party, when asked in a speech at Omak, Washington, on March 25, 1962, to give the complexion of the American Civil Liberties Union, replied:

"I say the color is a dirty red. It is not even a clean red...In some areas you will find that the policy of the Civil Liberties Union is to go right straight down the Communist party line all the way. Now, this is not a statement of opinion; it is a statement of fact. And if anyone wants to question that fact, I will challenge him to prove otherwise at any time.

"In other words, if you take the list of Communist party objectives, and if you take the policy of certain chapters of the Civil Liberties Union, you draw the parallel right across the page. They are identical all the way down."

DO YOU KNOW WE HAVE AN AMERICAN CIVIL LIBERTIES UNION MEDIA GOVERNOR'S RACE?

I interviewed the following gubernatorial candidates for Governor in the spring of 1986 regarding their knowledge about the ACLU.

It should be noted that Ed Fadeley's name was on the ACLU membership in the middle sixties. He said the ACLU set up an office in town and he just happened to join. I asked him how long he'd been a member. He said he'd been a member until three years ago.

Goldschmidt's response to the quote by Herb Philbrick was: "First of all, I don't like the way you phrased the question. Secondly, I would never base anything I do on what Herb Philbrick has to say."

Then I asked Goldschmidt how he felt about the ACLU. I mentioned HB 2663 from the 1985 legislature. This bill was at the request of the ACLU and it asked that 31 words be removed from law. These words were: NO TEXTBOOKS SHALL BE USED IN THE SCHOOLS WHICH SPEAKS SLIGHTINGLY OF THE FOUNDERS OF THE REPUBLIC OR OF THOSE WHO PRESERVE THE UNION OR WHICH BELITTLES OR UNDERVALUES THEIR WORK. It passed both houses and received the Governor's signature after he'd been given this documentation.

Goldschmidt said the ACLU protects civil or human rights. I asked him on May 6th at Chemeketa Community College if he had ever been a member of the ACLU and he said, "Yes, I used to be." Then I asked him if he was familiar with the ACLU origins. He never answered the question. Then I told him he should be warning the people of Oregon about this organization in light of HB 2663 and he never responded again.

Norma Paulus, while speaking at Willamette University about her trip to the Philippines, was read the quote by Herb Philbrick. I told her of the origins of the ACLU and she said "I totally disagree with everything you said". She then voluntarily admitted she'd been asked to be on their Board of Directors but turned it down because she was running for governor; she felt it would be a conflict of interest.

I told each gubernatorial candidate that William Foster was one of the original founders of the ACLU. He was also the head of the Communist party in 1932. He wrote a book called TOWARD A SOVIET AMERICA. In that book he called for a Department of Education and that all patriotic and religious themes were to be removed from the classroom (Example HB 2663).

Another founder was Lewis F. Budenz. He broke from the party in 1945 and became a militant anti-Communist.

Karl Prussian was a counterspy in the Communist party for the FBI for twelve years. In a speech in Portland, Oregon he said, "The so-called Civil Liberties Union that professes to represent your liberties and freedom will do this only on behalf of the left-wing (Communist) causes and never of the right-wing causes."

Only four legislators voted against HB 2663. I submit that the State of Oregon is about to be taken over by the ACLU.

The oath of office that any Governor must take says:

I do solemnly swear that I will support and defend the constitution of the United States against all enemies, foreign and domestic, that I will bear true faith and allegiance to the same: That I take this obligation freely without any mental reservation or purpose of evasion and that I will, well and faithfully discharge the duties of the office on which I am about to enter: so help me God.

Betty Freauf was the only gubernatorial candidate who was able to live up to that oath of office.

The four major goals of the ACLU are the same as those of the Communist Party - USA:

- (1) Remove God from our lives, i.e. the classroom
- (2) Destroy the family - support homosexual rights
- (3) Destroy property rights - socialistic taxation (2nd plank of Communist Party is our tax structure today.)
- (4) Keep criminals on the streets - (criminal rights?)

Chairman Bill Moshofsky has been given this information prior to it being sent to you and each of you receiving this letter are representatives of the people in the Republican party. You are responsible for looking out for the best interests of the voters, who elected you to be precinct people.

Therefore, I propose that Norma Paulus be charged with treason and immediately removed from the Governor's race. If totally supporting a major Communist front is not treason, what is? It is more noble to clear our own shop than be embarrassed by others outside the party. Betty Freauf should be appointed to run in her place.
